Thank you for your interest in Brandywine Valley Christian Preschool for your child's preschool experience. We look forward to providing a safe, nurturing and faith-based preschool experience. Please complete and return the enclosed registration forms as soon as possible to ensure your child's placement for next school year.

## **HOW TO REGISTER:**

- 1.) Fill out the enrollment form.
- 2.) Return the form with your \$100 non-refundable registration fee (per student). Forms can be turned in to the preschool office.

ALL new and returning students are required to prepay one month's tuition by July 15, 2025. This will be fully credited to your account to cover the last payment of the school year in May 2026. This payment is non-refundable. Additionally, ALL students are required to pay an annual supply fee of \$50. This covers child-specific art & academic materials as well as paper goods (cups, tissues, napkins, etc).

Registration is accepted on a first come, first served basis and registration forms will only be processed once the application fees are received.

Registration opens to currently enrolled students now. It will then open to the public on January 1, 2025.

For 2025/2026, our first day of school will be **Wednesday, September 3, 2025**. An informal open house will be held in early September to give your child an opportunity to see their classroom and meet their teachers prior to the start of school. Registration packets will be mailed in June. These packets include forms that will need to be completed and returned prior to the start of school. Children will not be able to start school until all required forms, including a current health appraisal, are on file.

## **2025/2026 SCHOOL YEAR REGISTRATION INFORMATION**

### **REGISTRATION FEE**

A \$100 non-refundable fee must accompany each child's enrollment form. This guarantees his/her class placement.

### **SUPPLY FEE**

Students pay a supply fee of \$50 annually, which is due with September tuition. This fee covers all general supplies (paper goods, etc) as well as child-specific art & academic supplies. This fee is in lieu of our former supply list (requesting paper towels, wipes, cups, etc).

### **PAYMENTS**

New and returning students are required to prepay one month's tuition by **July 15, 2025**. This will be fully credited to your account to cover the last payment of the school year in May 2026. This payment is non-refundable. Remaining tuition is divided into 8 equal payments. Your 2nd tuition payment will be due on or before **September 10, 2025**. Tuition may be turned in to the office, placed in the hallway lockbox or it can be placed within your student's class folder. Payments can be made in cash, check or money order (we unfortunately cannot accept payments via credit card). \*Checks can be made payable to BVCP\*. Payments received after the 10th of each month will incur a \$15 late fee. *Financial aid may be available.*

### **DELINQUENT PAYMENTS & RETURNED CHECKS**

Should payments become one (1) month delinquent, Brandywine Valley Christian Preschool reserves the right to dismiss the student unless the parent/guardian takes the initiative to make definite arrangements for payment. Returned checks will be accessed a \$30.00 fee and any fees imposed by our bank.

### **DISCOUNTS**

A 3% discount is given if the full school year's tuition is paid-in-full by **September 1, 2025**.

### **WITHDRAW**

If you need to withdraw your child from our program, please provide a 30-day written notice. Once a tuition payment has been made it is non-refundable if your child stops attending. This will include monthly and paid-in-full payments. Failure to provide a written notice will result in an extra month of tuition to be paid.

### **FINANCIAL ASSISTANCE**

A limited amount of assistance is available through scholarships. Please contact the Director for additional information.

### **EXTENDED CARE**

Before Care (8:00-9:00) is available all days in which school is in session. Advanced registration is not necessary.

**The daily fee is \$10.**

Stay-n-Play (12:00-1:30) is available most days in which school is in session (please see the calendar for any exceptions).

Advanced registration is not necessary. **The daily fee is \$15.**

Lunch Bunch (12:00-12:30) is available for students participating in extra-curricular activities (soccer, gymnastics, etc.).

**The daily fee is \$8** (this is separate from any activity fees and payable to BVCP directly).

*All extended care fees will be invoiced at the beginning of the month following the stay. All students participating in stay-n-play or lunch bunch are to send a nut-free lunch.*

# 2025/2026 SCHOOL YEAR TUITION

Tuition rates are based upon a yearly charge, divided into 9-monthly installments. Refunds are not made for absences, inclement weather closings, holidays, etc. Tuition rates are subject to change at any time at BVCP discretion.

Please note that your child must be age appropriate according to the State of Delaware Policy. This means that your child must be age X by August 31st to be in that classroom. (I.E. your child must be 3 prior to 8/31/25 to be enrolled in the 3-year old class.)
